Instant rebate on select G6, G6-R and 4k cameras

Valid December 1, 2017 through March 31, 2018.

This section sets out the Conditions for the Sony winter promotion and accompanying prizes

Description of promotion

1. By entering this promotion, entrants agree to be bound by these Terms and Conditions.
2. The Promotion will take place from the 1st December 2017 until 31 March 2018 (inclusive).
3. Promotor means Bosch Security Systems 130 Perinton Parkway, Fairport, NY 14450, as authorized reseller of Sony video security products (designated hereinafter as “Bosch”)
4. The Promotion entitles to a cash back/instant rebate for the purchase of Sony Video Security Products as set out hereafter:

Definitions:

Instant rebate means a cash back/instant rebate of \$35, \$45, \$235 or its equivalent in local currency as specified in the promotion details to be found on the attached “Winter Promotion Leaflet” for each Eligible Product purchased during the promotion period.

Eligible product means one of the following Sony video security products, sold by Bosch Security Systems: SNC-EB602R, SNC-EB632R, SNC-EM600, SNC-EM601, SNC-EM602RC, SNC-EM632RC, SNC-EB630, SNC-EM630, SNC-EM631, SNC-EM632RC, SNC-EB640, SNC-EB642R, SNC-EM641, SNC-EM642R, SNC-VM772R, purchased from a participating Sony video security distributor (DI) in the USA and Canada. Point of purchase must be a participating country throughout the sales region North America. Only purchase in USA qualifies for cashback. Otherwise no cash back will be executed.

1. **Eligibility:** To be eligible to claim the Instant Rebate, the entrant must:
Purchase an Eligible Product during the Promotion Period at a participating Sony video security DI; (b) the invoice date from the DI must be within promotion period; and (c) be aged 18 years or over. Multiple claims are permitted, subject to the following: (a) only one claim permitted per purchase of an Eligible Product; and (b) each claim must be submitted in accordance with the claim requirements specified in these Conditions.

2. **Nature of bonus:** The instant rebate may be granted by the participating DI to the buyer of the product.
3. **Combining bonuses and rebates:** In general, the instant rebate cannot be combined with other discounts or sales promotions. For exceptions please contact your sales partner.
4. **Already quoted projects:** The instant rebate cannot be used for quotations that have already been approved, for which invoicing is due during the promotional period.
5. **Deadline:** Instant rebate claims must be submitted by the DI and received by the Promoter strictly by 16 April 2018, covering claims within the promotional period. Claim forms received after this date will not be processed and no instant rebate will be issued.
6. **Bosch employees:** The Promotion is not open to employees of the Promoter and their immediate families (or their associated agencies).
7. **Verification:** The Promoter reserves the right, at any time, to verify the validity of claims and claimants (including a claimant's identity, age and place of residence) and to disqualify any claimant who submits a claim that is not in accordance with these Conditions or who tampers with the claiming process. Any misrepresentation or fraudulent information supplied by a claimant disqualifies their claim(s). Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
8. **Discretion:** The Promoter's decision on all matters pertaining to this Promotion is final and binding and no correspondence will be entered into, except as otherwise stated in these Conditions.
9. **Transferability:** Claims are not transferable or assignable.
10. **Modifications:** If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorized intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any claimant; or (b) to modify, suspend, terminate or cancel the Promotion, as appropriate.
